

# Privacy & Cookie Policy

At Jump Warehouse Great Yarmouth we are committed to protecting your information and respecting your privacy.

This notice sets out what personal information we may collect about you, how we may use it and your rights in relation to your personal information that we hold

## Why we may collect your information

We rely on the following legal reasons for collecting and processing your personal information:

- To fulfil a contract with you
- To comply with our legal and regulatory obligations
- In pursuit of our legitimate interests. This is when we have a reasonable business reason to use your information, including:
  - fulfilling our duties to our customers, colleagues and other stakeholders
  - selling and supplying services to our customers
  - protecting customers, employees and other individuals and maintaining their safety, health and welfare
  - promoting, marketing and advertising our products and services
  - sending promotional communications which are relevant and tailored to individual customers
  - understanding our customers' behaviour, activities, preferences, and needs
  - improving existing products and services
  - developing new products and services
  - handling customer contacts, queries, complaints or disputes
  - managing insurance claims by customers
- Where you give your consent. In general, we only rely on consent as a legal basis in relation to sending direct marketing communications to customers. See 'Marketing' for more.

## What information we may collect

Throughout your relationship with us we may collect various types of personal information, which we classify as follows. Of course, we don't collect all of this information from everyone, only as and when necessary.

- Identifying (e.g. Name, user name, online identifier)
- Contact (e.g. Email addresses, postal addresses, telephone numbers)
- Medical (e.g. Confirmation you are medically clear of specific ailments, which could have a detrimental effect on your ability to use a trampoline)

- Your Child/ren (e.g. Name, age)
- Communication (e.g. Emails, letters, web chat, telephone conversations)
- Social (e.g. Friends, colleagues, connections, groups)
- Public (e.g. Information in the public domain such as Companies House and social media)
- Preference (e.g. Consents, intentions, options)
- Location (e.g. Country, coordinates)
- Device (e.g. IP address, browser, device information)
- Behavioural (e.g. How and when you use our websites and services)
- Financial (e.g. Payment information)
- Professional (e.g. Employer, Job title, employer contact details)
- Demographic (e.g. Age and individual characteristics)

Additional Information we may collect from job applicants & employees:

- Identifying (e.g. National Insurance Number)
- Professional (e.g. Work history, education, references, interviews, employee files, disciplinary actions)
- Special Category (Only where permitted by law we may collect Medical Records through an Occupational Health service)
- Criminal Offence (Only where permitted by law we may collect data on unspent criminal convictions through the Disclosure & Barring Service)

These lists are not exhaustive and, in specific instances, we may need to collect additional data for the purposes outlined earlier in this notice.

### **How we might collect your information**

Your personal data may be collected:

- Directly, for example when you:
  - Purchase a service from us
  - Complete a risk acknowledgment and waiver form
  - Contact us via our websites, by phone, by email or by social media
  - Ask us for a quote or place an order
  - Sign up to our newsletter or updates
  - Enter competitions and prize draws
  - Interact with us in person including at exhibitions and networking events
  - Ask us to keep in touch with you;
  - Complete a survey or send us feedback about our websites, product or services
  - Apply for a job or begin employment with us

- Indirectly, for example your browsing activity or IP address
  - This may include the use of 'cookies. (See 'All about cookies' for more)
- From third parties that have your consent to pass your details to us
- From trusted third parties that we use to operate our business processes, products and services
- From public sources

We may obtain information about your computer & usage of our website and online services by using 'cookies'.

### **If you choose not to provide your information**

If you choose not to provide the personal information that we ask for, it may delay or prevent us from meeting our obligations. It may also mean that we cannot deliver or perform the products or services that you require from us.

Please note that any optional information that we ask for would be made clear at the point of collection.

### **Using your information for marketing**

If you agree, we would like to send you information about our products, services and events which we feel may be of interest to you.

If you have given your consent to marketing, you may opt out at a later date by contacting us (see 'How to contact us').

### **All about cookies**

We may obtain information about your computer & how you use our website and online services by using 'cookies'.

Cookies enable us to:

- Give you a better online experience
- Protect your security
- Measure and improve our service

We may set the following types of cookie:

- Strictly necessary cookies - necessary in order for you to use a feature
- Functionality cookies - records your preferences, allowing us to remember these for next time you visit
- Performance cookies - help us monitor usage to help us improve our products and services

These cookies may be 'session' or 'persistent'.

- Session cookies - not stored on your hard drive and only remain active until you close your browser.
- Persistent cookies - stored on your hard drive and remain active until they expire or you delete them manually.

Cookies may be set by us (known as 'first party' cookies) or, where necessary, by third party companies (known as 'third party' cookies).

The examples below are cookies that may be set via this website:

- **PHPSESSID, csrf\_cookie\_name**

Purpose: Validating the user is a human on the contact form

Type: Functionality, First Party

- **utma, utmb, utmc, utmt, utmz**

Purpose: Google Analytics tracking code to enable us to monitor statistical usage data

Type: Performance, Third Party

- **gwcc**

Purpose: Google Adwords tracking code to enable us to log volume of 'click to call' conversions from search engine adverts

Type: Performance, Third Party

- **cfduid**

Purpose: HelpOnClick cookie to facilitate live chat functionality

Type: Strictly Necessary, Third Party

## **Managing Cookies**

Most web browsers allow some control of most cookies through the browser settings. ### **How long we keep your information for**

We will retain your personal information for no longer than necessary to fulfill the purposes outlined in this Privacy Policy unless we cannot delete it for legal, regulatory or technical reasons. We may also keep it for statistical purposes. If we do so, we will make sure that your privacy is protected and only use it for those purposes.

### **Sharing your information**

We may share your personal information with these types of organisations:

Applies to Everyone

- Third party organisations that we use to operate our business processes, products and services
- Government and regulators
- Credit reference agencies, law enforcement and fraud prevention agencies
- Individuals or companies that introduce you to us
- Individuals or companies that we introduce you to
- Market researchers
- Any organisation that you request we share your information with
- A prospective buyer of our business or assets

Applies to Employees

- Our accountants, solicitors and payroll provider
- Employee benefit scheme operators
- Our pension scheme operator
- Occupational health practitioners

Please note: We will not provide your personal information to other organisations for marketing purposes.

### **Sending information outside of the EEA**

The personal information that we collect from you, or you provide to us, may be transferred to, and stored at, a destination outside the European Economic Area ("EEA") only if necessary to:

- Follow your instructions
- Comply with a legal duty
- Fulfil a contract with you or
- Work with a third party that we use to operate our business processes, products and services

In such cases, we take reasonable steps to choose established companies in countries with privacy laws recognised as ensuring an adequate level of protection or established companies that employ measures deemed to give similar protection, such as the EU-US Privacy Shield framework.

## **Your rights**

Once we hold your personal information, you have the right to:

- Request a copy of the personal information we hold about you
  - You can also request a copy of some of your information in an electronic format so it can be passed to another organisation.
- Request that we rectify anything incorrect in your personal information
  - If something is incorrect, we'll do our best to rectify it.
- Request that we delete your personal information
  - Remember that if you ask us to delete your information we won't be able to provide you with our services. There may be legal reasons why we can't delete your information but we'll tell you if this is the case.
- Request that we restrict the processing your personal information
  - You can ask us to stop processing your data but not delete it, for example if something is incorrect and it's not yet rectified, it has been used unlawfully or it is no longer relevant.
- Object to the processing of your data
  - You can object to the way in which your data is used, including for direct marketing.
- Withdraw any consent you have previously given
  - Remember that if you withdraw your consent we may not be able to provide you with our services.

## Automated Decision Making

In certain cases under data protection law you have the right to request that your personal information isn't used to make automated decisions, instead requesting human intervention. At this time we don't make any automated decisions based on your personal information.
